- Commemorate the 1965 Watts Rebellion with action beyond words
- Support and catalyze change in policing policy and practice
- Host and document community voices for the public record
- Create and strengthen relationships of trust to support needed collaboration

- Partnership with 20 anchor community organizations
- 169 speakers in 17+ hours of testimony during 6 public community hearings in different regions of the county
- 8 representative law enforcement leaders in dialogue with 13 subject matter experts in the final public hearing
- 38 stakeholder feedback sessions with 42 groups and organizations
- Support from 2 academic partners
- Continuing dialogue, partnership, and collaboration



Two Main Themes for Needed Change to Redefine Policing with Our Community

- Structure policing as one component of communitydefined, community-led public safety.
- Demilitarize, and comprehensively transform, policing culture.

Highlights:

- Eliminate qualified immunity for law enforcement officers
- Use alternatives other than arrest for quality of life violations and crimes of survival
- Provide public access to complaint and misconduct records
- Require special independent prosecutors for use-of-force investigations
- Reallocate funding to expand and fully resource non-law enforcement community alternatives and crisis response teams
- Use Racial & Identity Profiling data to end systemic racism
