Executive Director Capri Maddox shared the following update with the commission:

- The Reparations Advisory Commission will hold its inaugural first meeting
- The CHRED will welcome four new interns from USC and UCLA respectively.

- Highlighted a motion in City Council that would update the City Seal and Flag to include local Indigenous and Native populations
- Tracking a City Council Motion that focuses on gender equity in spots
- Brief update on the Office of Racial Equity's racial equity audits
- Held 6 Know Your Rights and Bystander Intervention Trainings
- Hosted and participated in the first annual Tom LaBonge Day of Service, held at six locations throughout the City. Commissioners representing the department showed their support by volunteering and attending various sites and locations throughout the City
- Department personnel will participate in Spanish Language forum focused on employment rights and justice for workers

### V. PRESENTATIONS FOR FILIPINO AMERICAN HISTORY MONTH CELEBRATION

- Melany De La Cruz-Viesca, Human Relations Commissioner gave an overview of FilAm History Month.
- Dr. Joe Bernardo, Diversity, Equity, and Inclusion Associate at Loyola Marymount University gave a presentation on Filipino-American history in Los Angeles in honor of celebrating Filipino American Heritage Month.
- Allen Galeon, Filipino Workers Center, Caregiver and Worker shared his personal story and experiences to celebrate Filipino History Month.
