5. GENERAL MANAGER'S REPORT:

Claudia Luna, Assistant General Manager gave the GM Report on behalf of Capri Maddox, General Manager and Executive Officer. She noted several highlights from the 2021 LA Civil Rights year end in review. CHRED accomplished the following: Along with the Mayor's Office and Council Members launched the Reparations Advisory Council; Launched the largest antihate PSA campaign in City Government history; Created the L.A. Repair Innovation Fund, LA's first Participatory Budget Pilot program which will bring 8.5 million dollars to 9 underserved LA communities; Held events to vaccinate hundreds of Angelenos against COVID-19; Published the Department's report calling for equity in disaster response; Trained hundreds of Angelenos on hate prevention; Led two days of service for the Tom LaBonge Day of Service; The Human Relations Commission published its report on policing in South LA; Created multi-lingual programming on standing up to workplace discrimination; In partnership with NFL Media and LA Partners in Homeownership held workshops to aid first time home buyers; Launched the LA for All partnership with Cal State LA students; and opened the CHRED offices and the John Lewis Conference Center. She also noted that the Department hired a consultant for the Department's Strategic Plan.

6. TAC REPORT:

Karina Samala, Chair of the Transgender Advisory Council spoke in memoriam of two close colleagues who passed in December of 2021. Ms. Zamora and Ms. Monroy were held in remembrance.

7. NEW BUSINESS:

The Commission discussed the formation of an Ad Hoc Committee to commemorate the 1992 Civil Unrest. Francisco Ortega, Senior Project Coordinator opened the discussion
