Regular Meeting Minutes April 14, 2022 2:00 p.m.

1. CALL TO ORDER, ROLL CALL

Commission Chair Leslie Ivie called the meeting to order at 2:07 p.m. She opened the meeting with an acknowledgement of Arab American Heritage Month and highlighted some of the contributions of the Arab American communities being celebrated during the month of April.

Commissioners in attendance included Commission Vice Chair Helena Marissa Montes, along with Commissioners Keith Parker, and Aziza Hasan.

Also in attendance were Capri Maddox, Executive Director and General Manager; Claudia Luna, Assistant General Manager; Heather Aubry, Deputy City Attorney; and Joumana Silyan-Saba, Director of Policy & Discrimination Enforcement.

A quorum was established and the meeting proceeded.

2. PUBLIC COMMENT PERIOD

The public comment period was opened but there were no speakers to address the Commission, therefore public comment was closed.

She noted the three phases of the process which include assessment, investigation, and enforcement. Ms. Silyan-Saba referenced the distinctions of the role of the Commission on Civil Rights during the enforcement phase to include subpoena requests, approvals of agreements and the appeals process. In commemoration of the 30th Anniversary of the Civil unrest in Los Angeles, the Civil Rights Department will be participating in a number of community events and helping to coordinate memorial efforts throughout the City; and

The Department recently hired additional staff.

7. ANNOUNCEMENTS:

Commissioner Hasan mentioned that the Loyola Immigrant Justice Clinic will celebrate its 10-year anniversary with a party that will occur on June 6, 2022.

Ms. Silyan-Saba recognized the Arab American community then acknowledged Deputy City Attorney Heather Aubry for her guidance in the development of the discrimination overview document. She commended the support of intern Brooke Helmick, and intern Conner Ripple for his design work.
